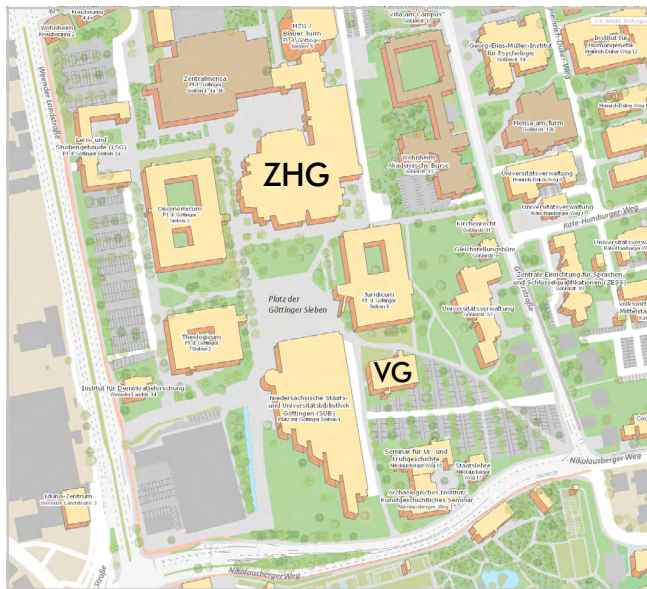

Zentrales Hörsaal Gebäude (ZHG)

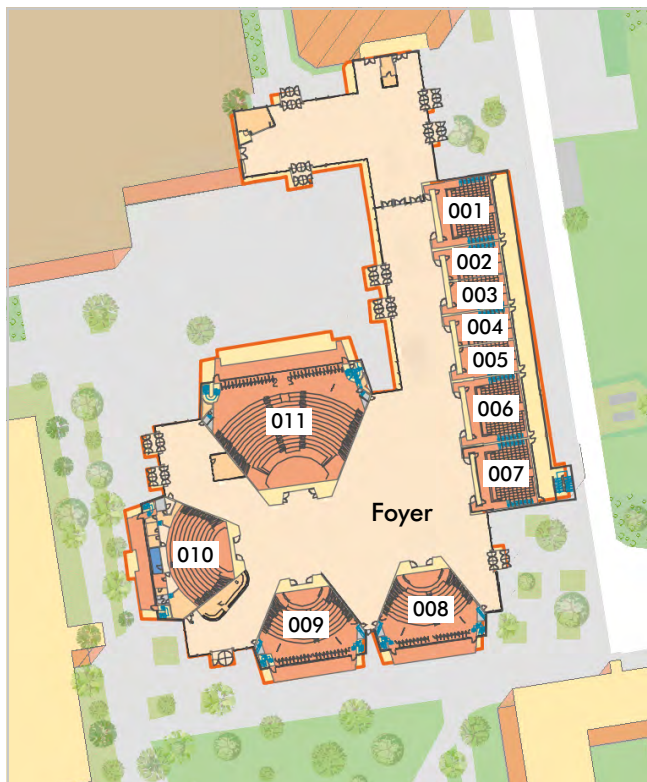
